2. The Scholarship Committee will consider financial need.
3. Application must be postmarked by November 15, 2011
4. Two letters of recommendation must accompany each application.
5. The Scholarship Committed will make the final selection of the recipient. If there are no qualified applicants, the Scholarship Committed reserves the right to withhold the scholarship.
6. Award money must be used during the 12 months immediately following the presentation in April, 2012.
7. Progress updates will be required.
8. Alameda County Chapter will disburse funds at the discretion of the Scholarship Committee directly to the flight school.
9. Scholarship winner will be notified by February 15, 2012
